**PUBLIC NOTICE**

It is to inform all the concerned stakeholders that honorable Judicial Commission (Water Commission) constituted by the honorable Supreme Court of Pakistan has issued directions vide Order dated 25-06-2018, 26-06-2018, 03-09-2018, 06-09-2018 to the all concerned industrialists regarding installation of Septic Tanks and Waste Water Treatment Plant within their units. The concerned owners of industries shall have to install Septic Tanks and Waste Water Treatment Plants within stipulated time in their Industrial Units Working within the jurisdiction of the province of Sindh. In case of failure, appropriate legal proceedings under SEP Act shall be initiated against those industrial units which have not complied with the orders of Honorable Water Commission.

In this regard, it is further informed to all those owners / chief executive officers of industrial units in the province of Sindh who have not yet received any directions either from Water Commission or from Sindh Environmental Protection Agency, are advised to install Septic Tanks in case of dry process **within two months** and Waste Water Treatment Plant **within four months** in case of wet process in their units.

In case of failure, the Sindh Environmental Protection Agency shall initiate legal proceedings against defaulters as per Sindh Environmental Protection Act, 2014.
