No. SO(J-I)/HD/8-1(04)/2020-Corona. In pursuance of the Government of Sindh Notification bearing No. SO(CTC)/SGA&CD/COVID-19/Committee/2020 dated 24.03.2020 and 08.04.2020 constituting a Committee {consisting of Additional Chief Secretary (Home) as Chairman, Secretary (General Administration), Secretary Industries & Commerce and Commissioner Karachi Division as Members, and Secretary Labour & Human Resource as Member / Secretary} constituted to redress and resolve any issues of importers and exporters that may crop up during the lockdown in Sindh, the committee examined the requests / applications received from the export-oriented industries in the light of Home Department Order of even No. dated 14th April 2020, wherein such industries were allowed to operate subject to the condition of ensuring adherence to SOPs bearing even No. dated 14th April 2020, issued by Home Department in view of COVID-19.

2.
