SITE ASSOCIATION OF INDUSTRY

SITE Association of Industry represents the single largest industrial base in the country in terms of size/area, number of units, industrial output, revenue to the exchequer and export volumes.

SITE has come a long way since Quaid-e-Azam Muhammad Ali Jinnah inaugurated the first Industrial unit in the country and laid the stone of the first Industrial area in Pakistan: The Sind Industrial Trading Estate (S.I.T.E.) on 26th September 1947.

SITE's contribution to the national exchequer stands around 30% of the >50% that Karachi contributes in terms of overall Federal, Provincial taxes and levies. SITE area is also the single largest employer of industrial workers in the country, providing direct jobs to 550,000 families and indirectly providing livelihood to hundreds and thousands of beneficiaries.

The thrust of SAI's endeavour is to save the Industry from going into extinction, preserve jobs provided by the Industries and strengthen the role of Industrial sector for contributing towards the exchequer.

HISTORY OF SITE AREA

SITE area Karachi is the first, oldest & largest industrial zone of Pakistan. Father of the Nation, Quaid-e-Azam Muhammad Ali Jinnah himself laid the foundation stone of the first industrial undertaking after Independence in S.I.T.E. are Karachi on 16th September 1947.

ESTATE AREA AND INDUSTRIES

There are approx. 3500 to 4000 industrial units of varying sizes in the estate, spread over approx. 4,700 Acres. These include all kinds of textiles, ready-made garments, silk, engineering, automobiles, beverages, oil, soap, foodstuffs, chemicals, pharmaceuticals, steel, glass, paints, filament yarn etc.

JOBS / REVENUE

SITE area is the largest employer of industrial workers in the country with approx. 0.55 million jobs through direct employment and thousands of indirect beneficiaries. Karachi contributes 65% to the entire collection of National Treasury, out of which the share of SITE is nearly 30%. The Total Exports of exporting industries located in SITE area are 2.3 billion dollar per annum.

MAJOR ADVOCACY & EVENTS DURING THE YEAR

I. Construction of Roads

So far, total 27 Roads have been constructed and many others are under construction.

II. Law & Order & Security

SITE Self Security System has entered into the 10th year of successful operation which has resulted in decline of crime rate in SITE area as compared to other areas of the city.

III. Fire incidents

More than 40 fire incidents took place during the year on which, quick action were taken and fire tenders were sent within minutes which saved the effected industries from colossal losses.

IV. Gas supply to Industries

Efforts were made the whole year to ensure smooth supply of gas to industries. SSGC is facing gas shortage due to fast depletion of gas fields and a mix blend of Indigenous + RLNG has been worked out to contain the problem.

V. Issues related to Labour Dept.

Labour Helpdesk EOBI / SESSI remained active round the year and immediate action were taken on members' complaints.

VI. Construction of Industry House

A comprehensive proposal has been submitted to the Export Development Fund with an initial fund request for PKR 835 billion which is expected to be approved in the next EDF Board meeting.

VII. Proposals for Federal Budget 2023-34

SAI's Proposal for the Federal Budget 2023-24 covered the following areas:

 a) Preserving and promoting the Industrial sector which unfortunately is in a dire state so as to let it revive its contribution towards import substitution; export promotion; job creation and higher contribution in Government's revenue generation drive, however, only as a result of



- substantial increase in Industrial output and certainly by not regressively taxing the already and highly taxed Industrial sector.
- b) Removing the undue and unnecessary curbs on the inputs of Industrial sector in the wake of on-going economic crisis.
- c) Bringing the cost of doing business in Pakistan at par with its peers.
- d) Efficiency measures aimed at improving the competitiveness of Pakistani Industries thereby bringing it at par with Regional and International competitors.

VIII. Diplomatic visits

Despite unfavorable business atmosphere, a 21-Member businessmen delegation from Iran visited SITE Association of Industry and selected factories in SITE area. Consul General of Iran Mr. Hassan Nourian and Commercial Consul Mr. Hussain Amini also graced the occasion.

IX. DGTO License Renewal

The DGTO License of SITE Association of Industry, which was pending since two years, has been renewed for a period of 5 years, valid till 20th June 2026.

X. Industry-Academia Interaction

During the year, interactions and meetings were held with Mehran University of Engineering & Technology (MUET), National University of Science & Technology (NUST) and Institute of Business Administration (IBA). NUST is going to set up an ICON CENTRE in the premises of the Association.

XI. Untoward incident in SITE factory

During Ramzan Ration Distribution drive in a SITE area factory, an stampede inadvertently occurred which unfortunately resulted in loss of several desperate lives. The factory owner who distributed the zakat in good faith, unfortunately landed into detention, however was released before Eid-ul-Fitr with the blessings of Almighty ALLAH and with the efforts of the SITE Association of Industry.

EFP WORKSHOP ON ILS AND OSH CONVENTIONS

EFP organized Employers' Workshop on International Labour Standards (ILS) and OSH Conventions at local hotel on 16th November 2022. It focused on 5 fundamental rules which included Freedom of Association (FOA), all forms of Forced Labour (FL), Child Labour (CL), Discrimination in respect of employment and occupation (D) and Safe & Healthy Working Environment for all labour (OSH). FL has been totally banned since 2022. If Pakistan will not adopt compliances it will lose GSP plus status in December 2023. 80pc



factories of Pakistan are compliant with international standards. EC Member Muhammad Riaz Dhedhi represented the Association at this forum.

WORKSHOP ON ILS AND ILS REPORTING OBLIGATIONS

A two-day Capacity Building Workshop on ILS, ILS Reporting obligations, ILO Supervisory was organized by Ministry of Overseas Pakistanis & Human Resources Development in collaboration with ILO on 17th & 18th November 2022. On the first day, Key points discussed in the meeting included minimum age of admission to employers and workers, all the labour laws after the 18th amendment transferred to provinces, use of children by terrorist and extremists groups, sale & trafficking of children etc.

The 2nd day, the session focused on Labour Inspection Convention. Briefing was given on laws & condition of work and protection of workers. Labour Inspector must be public official, qualified technical expert, both gender of forces. Number of labour inspectors depends on size of the firm. Power & Obligations of Labour Inspector, can enter freely at any time with / without prior notice. Measures to remedy defects, guidance to employers to improve and impose penalty in case of non-compliance. The workshop was attended by Khalid Riaz on the first day and Azeem Motiwala on the 2nd day.

425TH MEETING OF BOD OF SITE LIMITED

425th meeting of Board of Directors of SITE Limited was held in the office of SITE Limited on 18th November 2022. Tenant Directors namely Zubair Motiwala, Jawed Biwani, Haroon Farooki, Abdul Razzak Agar and President Riaz Uddin attended the BOD meeting. SITE Association of Industry convened meeting of general members who effected due to discontinuation of RCET of Rs.19.99 per kWh tariff for export-oriented sectors on 10th April 2023. The meeting was largely attended by approx. 150 members. It was decided to issue a Press Statement stating that that this act of the government is detrimental for exporters as most of the SMEs effected are indirect exporters and are closely weaved into the entire supply chain of exporting industries. In such difficult times when the nation is in dire need of foreign exchange, this anti-competition move will further erode the competitiveness of the local exporting industries, resulting in further shrinkage of exports which stood at USD 32 billion in FY 2021-22 and are feared to go down to USD 27-28 billion in the current fiscal year.

MEETING OF GOVERNER SINDH WITH SINDH INDUSTRIAL LIAISON COMMITTEE:

A meeting of SILC was held at Governor House on 18th April 2023 under the Chairmanship of Governor of Sindh Mr. Muhammad Kamran Tessori. After detailed discussion, the following two decisions were taken in the meeting.

> The matter of commensurate allocation for development of industrial areas of Karachi in export Development Fund shall be taken up during the meeting with Prime Minister. Members of SILC to carry out complete homework for appropriate presentation of the



- case before Prime Minister. Mr. Zahid Saeed to obtain input from all members and finalise the draft presentation.
- The Governor directed President SITE Association to prepare a comprehensive representation covering all administrative and legal aspects with regard to the proposed reforms and enhanced role of SITE Association in the management of SITE LIMITED.

We have argued that for preparing and submitting the aforesaid petition, spread over **724 pages**, the petitioner must have engaged, for many months, scores of its employees from technical, financial and legal departments along with assistance from outside professionals. If the petitioner itself needs several thousand-man hours for the job, how



can the Authority expect from the commoners and simpletons who know nothing about electricity, to file their comments within 7 days?

build the capacity of SMEs to better understand the important labour laws and related issues in their implementation and to effectively respond to those issues. Key Speaker was Fasihul Karim Siddiqui (Senior Legal Advisor, EFP). EFP). More than 100 Members of the Association attended the awareness session.

BUDGET PROPOSALS

For the 3rd consecutive year, SITE Association of Industry sent comprehensive Budget Proposals to the federal government. The text of press release issued in this respect is being re-produced below.



"SAI recommends strong measures for Federal Budget 2023-24.

KARACHI (May 23, 2023): The SITE Association of Industry (SAI) has recommended the Government to save industries from closure, prevent further unemployment and strengthen the role of the Industrial sector in import-substitution and export-promotion.

SAI urged the government to remove unannounced and imprudent restrictions on imported raw material, machinery and spares since such reckless curbs have brought down the output of the Industrial sector which has further deepened the ongoing economic crisis thereby putting the collection of government's own tax targets into jeopardy.

Overall, the inflation and rising cost of doing business coupled with lending rates for industry, as high as 22-23% have broken the backbone of the economy. The government needs to take immediate measures to save the industrial sector from falling sick — a dire state, which, if allowed to go unabated, would never be reversible in the future.



The State Bank of Pakistan's (SBP) EPD Circular No 20 of 2022, has created more problems than it could have solved and some of its provisions are in contravention of the SBP Foreign Exchange Regulation/Manual, it said.

The abovementioned circular needs elaboration, clarification and amendments to the extent of providing a complete framework of what SBP calls "self-funded imports", it demanded.

The industry representative body also pointed out the perennial issue of low tax-to-GDP ratio, narrow tax base and the counterproductive taxation policies which provide incentives the non-taxpayers rather than incentivizing the honest tax payers which is a critical factor for promoting a documented economy and a thriving formal sector.

The Association recommended a unified tax number for both income and sales tax and no sizeable business should be allowed to operate without acquiring a tax registration certificate and this should be the responsibility and a key accountability of FBR.

The plethora of withholding and presumptive tax provisions have distorted the whole 'income tax' regime which has become anything but not really a tax on income! Presumptive and withholding regime needs to be consolidated and systematically replaced with a 'tax on income', says the SAI proposals.

SAI demanded reduction in the rates of turnover tax by at least 50 per cent from the current year thereby allowing the businesses pay income tax according to their assessable income and pay or adjust sales tax according to their actual turnover and value addition.

Other proposals included reduction in the general sales tax (GST) rate from 18 to 15 per cent and abolishing 3% further sales tax on unregistered persons while making it mandatory for FBR to register every sizeable business for sales tax purpose.

Tax refunds should be expedited within 60 days of refund application otherwise the sales tax zero-rating of the whole supply chain of zero-rated goods should be restored.

Rampant under invoicing and misdeclaration is badly damaging the local Industry and depriving the exchequer of its much-needed revenue. SAI recommended consolidation of varying rates of statutory custom duty, additional custom duty and regulatory duty into 'one custom duty' with a maximum slab of 25% while appropriately cascading the tariff structure, i.e., starting rate of 0% on raw materials with increasing tariff rates, with



stages of production and value addition up to the finished product level. Such a move would render smuggling unviable and clandestine imports unfeasible.

SAI President Riaz Uddin addressing budget proposals to the Minister of Finance, Governor State Bank and Chairman FBR hoped that the recommendations would meet approval in the best interest of the country.
