Subject: **SERIOUS CONCERN REGARDING THE ARRIVAL AND DEPARTURE OF CHINESE NATIONALS IN SITE INDUSTRIAL AREA.**


I am bringing to your urgent attention a matter of serious concern regarding the arrival and departure of Chinese nationals in the SITE Industrial Area without prior intimation to the local police or the SITE Association. This issue poses significant security concerns, especially given the heightened threats in the city.

On October 7, 2024, a Chinese national, namely [REDACTED] Sanba, arrived at Plot No. E-297/A China Young China Plate Making Company [REDACTED], SITE Karachi without any prior information or permission. This incident resulted in the immediate arrest of [REDACTED] who serves as the Focal Person for the Chinese nationals at the aforementioned company, for failing to comply with the mandatory reporting procedure. A case was registered under FIR No. [REDACTED] at PS SITE-A in accordance with the **Sindh Security of Vulnerable Establishment Act-2015**. Despite strict instructions and directives from higher authorities, the management of this project neglected to inform the local police about the arrival of the Chinese national. Such negligence could lead to serious consequences, especially considering the current threats against Chinese nationals.

In this regard, I once again request that a formal letter be issued to all industrialists and factory owners in the area, emphasizing that **it is mandatory to inform the local police about the arrival or departure of any Chinese nationals**. Due to the ongoing security situation, the movement of Chinese nationals in the District Keamari is strictly stopped until **October 17, 2024**.

Furthermore, it is mandatory that companies and factory managements arrange **bulletproof vehicles and well-trained security guards** for the movement of Chinese nationals. No compromise will be made on this matter. If any company management urgently requires the movement of Chinese nationals, they must first coordinate with the local police, and any movement will only be allowed after police approval.

Failure to comply with these directives will result in **immediate legal action** against the management involved. Your cooperation in ensuring the safety of Chinese nationals is essential in preventing any unfortunate incident and in maintaining the strong bond between our two countries.
