ORDER / DECISIONS OF IMPORT & EXPORT COMMITTEE - 09

No. SO(J-I)/HD/8-1(04)/2020-Corona. In pursuance of the Government of Sindh Notification bearing No. SO(CTC)/SGA&CD/COVID-19/Committee/2020 dated 24.03.2020 and 08.04.2020, and Committee constituted vide Home Department, Government of Sindh Notification bearing No. SO(Jud-I)HD/8-1(04)/2020-Corona dated 28th April, 2020, the committee-I examined the requests / applications received from the export-oriented industries in the light of Home Department Order No. SO(Jud-I)HD/8-1(04)/2020-Corona dated 14th April 2020, wherein such industries were allowed to operate subject to the condition of ensuring adherence to SOPs bearing No. SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs dated 14th April 2020, issued by Home Department in view of COVID-19 measures.

Now, therefore, on the recommendations received from the Secretary, Industries & Commerce Department / Chairman, Committee-I vide letter No. I&CD/F.P/HOME-001/2020 dated 2nd May 2020, the following export-oriented factories / manufacturing units, which are found fulfilling the criteria as per the Order and SOPs referred above {i.e. (i) Verification of export order by TDAP, (ii) Undertaking by CEO/owner on ensuring arrangements within their premises as per SOPs referred above for COVID – 19 prevention, and (iii) List of workers/staff/management who will be present/working in the premises of factory/manufacturing unit during its operation}. These units are permitted to start their operation (for export related items) subject to adherence to the SOPs.
