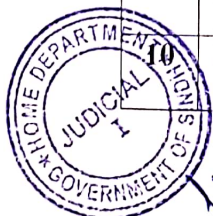

**ORDER/DECISIONS OF IMPORT & EXPORT COMMITTEE - 14**

**No. SO(J-I)/HD/8-1(04)/2020-Corona/IEC-XIV.** In pursuance of the Government of Sindh Notification bearing No. SO(CTC)/SGA&CD/COVID-19/Committee/2020 dated 24.03.2020 and 08.04.2020, and Committee constituted vide Home Department, Government of Sindh Notification bearing No. SO(Jud-I)HD/8-1(04)/2020-Corona dated 28<sup>th</sup> April, 2020, the sub-committee-I examined the requests/applications received from the export-oriented industries in the light of Home Department Order No. SO(Jud-I)HD/8-1(04)/2020-Corona dated 14<sup>th</sup> April 2020, wherein such industries were allowed to operate subject to the condition of ensuring adherence to SOPs bearing No. SO(Jud-I)HD/8-1(04)/2020-Corona/SOPs dated 14<sup>th</sup> April 2020, issued by Home Department in view of COVID-19 measures.

2. Now, therefore, on the recommendations received from the Secretary, Industries & Commerce Department, / Chairman, Sub-Committee-I vide letter No. I&CD/F.P/HOME-004/2020 dated 12<sup>th</sup> May 2020, the following export-oriented factories/manufacturing units, which are found fulfilling the criteria as per the Order and SOPs referred above {i.e. (i) Verification of export order by TDAP, (ii) Undertaking by CEO/owner on ensuring arrangements within their premises as per SOPs referred above for COVID - 19 prevention, and (iii) List of workers/staff/management who will be present/working in the premises of factory/manufacturing unit during its operation}. These units are permitted to start their operation (for export related items) subject to adherence to the SOPs.

It is reiterated that the SOPs are put in place with a view to prevent the spread of COVID-19, therefore, **it is absolutely necessary that the SOPs are in place before the start of work as per undertaking given.** Moreover, in order to ensure timely tracking and tracing in case a positive case is detected, the required particulars of all the staff/workers/management who would be present in the premises of the factory/manufacturing unit are to be provided. The required details are name, father's name, designation, CNIC Number, residential address, cell number (if any).
